POLICY PLAN

Magdalena Trybulec Foundation (MTF) is established in memory of Magdalena who wanted to help the children of Togo through a foundation. After her death, her family and friends decided to formalize that idea by founding the Magdalena Trybulec foundation.

OUR GOALS

Promote the well-being of orphans and provide assistance to children in precarious situations, in Togo (Lome, the capital)

OUR ACTIVITIES

- 1. Maintain contact with the orphanage leaders and the volunteers in Togo who know the target group of orphans and children in vulnerable situations well.**
- 2- Needs assessment as a basis for determining which activity training of children for work and learning.**
- 3- Providing financial and material assistance to the children and training for the older children so that they can find work.**
- 4- Organization of trips to Togo by volunteers and donors of the Foundation, to meet the children**
- 5- Fundraising and mobilizing donations to fund activities.**
- 6- Communication with donors and external financiers through social media and newsletters**
- 7- Promotional activities to raise fond and looking for donors.**

- 1. Friends, relatives and acquaintances of Magdalena Trybulec are invited to make donations.**
- 2. External funds such as Wilde Ganzen, Aelbrechtsfonds and Deaconies of friendly churches are requested to contribute to the financing.**
- 3. African objects such as wood carvings, baskets, jewelry etc and t-shirts with the Magdalena Trybulec Foundation logo are sold and the profit is used for the activities.**
- 4. Target figure for the medium term is 10,000 euros per year. This will approximately finance the costs of 40-50 children living in two orphanages that MTF wants to partner with. The target figure of 10,000 is realistic, assuming a circle of 30 private donors and two or three outside funds.**

MANAGE EQUITY

It is expected that income will be spent within a year to support the orphans and children in vulnerable situations. It is conceivable that in the event of successful fundraising, a reserve of a maximum of 7,000 euros (70% of the planned annual budget) will be created. This equity remains in the bank account of the Foundation: the ING business account has the option of linking a savings account to it. Decision-making for the use of equity capital is based on commonality in the board. If the reserve threatens exceed 7,000 euros, activities will be scaled up: a third orphanage or local aid organization for children in Togo will then be identified.

FINANCIAL MANAGEMENT

The treasurer takes care of transfers to Togo, at the request of the chairman and the secretary. She checks whether the transfer is in accordance with the agreements. The treasurer prepares a quarterly financial statement and submits this to the other board members. This overview is used to make

adjustments to income and expenditure. Each year, the treasurer prepares a financial annual report and submits it to the board for approval. It will then be published on the website and incorporated into the newsletter for donors and external financiers.
